- Purchase requests before 4 p.m. Eastern Time will receive that business day's price. Purchase requests after 4 p.m. will receive next business day's price.
  - Proceeds will usually be deposited/debited to your bank account within two business days after the receipt of your ACH purchase or redemption request, provided that the request is in good order.
  - The minimum on-demand ACH purchase or redemption amount is \$50; the maximum is \$100,000.
  - If name and/or address on this bank account is different from that appearing in the account registration, a signature guarantee is required.

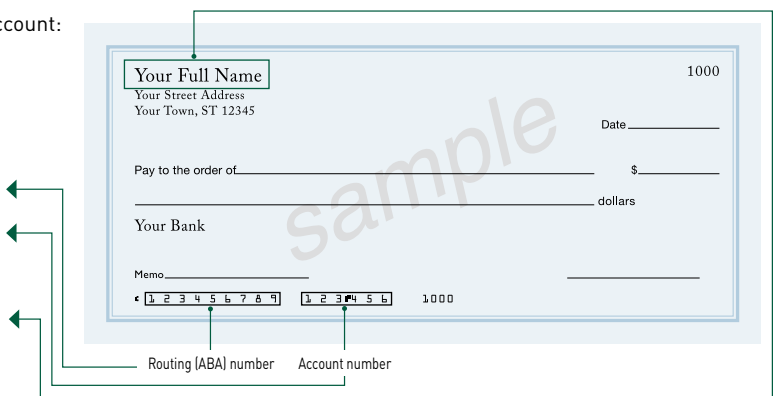

A notarization from a notary public does not meet Medallion Signature Guarantee requirements. Medallion Signature Guarantees must cover the amount of the requested transaction. There are several different guarantee amounts, so it is important to acquire a guarantee amount equal to or greater than the amount of the transaction(s).
